## **MUNICH CHAPTER PRIVACY NOTICE**

**Effective: June 2025**

The **AHEPA Munich Chapter (A618)** (“we”, “our”, “us”) is committed to protecting your personal data in accordance with the General Data Protection Regulation (GDPR).

This notice explains how we process your personal information when you submit the Membership Application Form and the Member Update Form.

### **1. Data Controller**

### **2. Data Collected**

Depending on the form you submit, we may collect:

- Name, date of birth, nationality
- Identification details (e.g. passport or ID no)
- Postal address, email and phone numbers
- Membership history, AHEPA chapter affiliation
- Veteran status, Sons of Pericles affiliation (where applicable)
- Status updates (e.g. reinstatement, deceased member notifications)

### **3. Purpose & Legal Basis of Processing**

We collect and process your personal information solely to:

- Evaluate and administer your AHEPA membership
- Maintain accurate and up-to-date membership records
- Communicate with you regarding chapter updates, dues and events
- Ensure correct internal reporting and member status data

#### **a. Legal basis under GDPR:**

Article 6(1)(a)- Consent- when you voluntarily provide optional personal data (e.g. veteran status)

Article 6(1)(b)- Performance of a contract (membership services)

Article 6(1)(f)- Legitimate interests (member management & administration)

#### **4. Data Retention**

We retain your personal data for as long as necessary to meet our membership obligations and legal requirements. Member records are kept for the duration of your membership and may be archived for historical or organisational purposes, unless you request erasure, subject to legal limitations

#### **5. Data Sharing**

Your personal information is processed by authorised officers of the AHEPA Munich Chapter (A618). It is shared with:

- AHEPA District 28
- The AHEPA Main Chapter in the United States
- Other affiliated AHEPA chapters as needed
- Trusted third-party service providers who support our organisational activities, such as membership management, event coordination, IT services and communications

We ensure that all third parties with access to your data are contractually bound to uphold appropriate data protection and confidentiality standards.

#### **6. Your Rights under GDPR**

You have the right to:

- Access your data
- Rectify inaccurate data
- Request erasure (“right to be forgotten”)
- Restrict or object to processing
- Lodge a complaint with the supervisory authority
